8/5/1901		Granting a franchise to St. Marys Electric Company (West Penn Power) to provide the Borough with all the necessary fixtures to provide electricity to the public.
231	5/27/1913	Executing a contract between the Borough and R.M. Sutton for the paving, curbing and sewerage portions of streets in the Borough.
244	6/25/1914	Executing a contract between the Borough and McCarthy and O'Herron for the paving, curbing and sewerage of a portion of Bruxelles Street.
245	6/30/1914	Executing a contract between the Borough and Joe Weisner for the paving, curbing and sewerage of certain streets in the Borough.
253	7/31/1916	Executing a contract between the Borough and Joe Weisner for the purpose of paving, curbing and sewerage certain roads in the Borough.
274	10/3/1921	Authorizing the installation of ornamental illumination of Erie Avenue.
353	5/22/1936	Authorizing an agreement with West Penn Power Company for lighting the Borough with electric light.
