Zito Media Contract

Manager Pearson explained the following were the major changes in the agreement:

Section 1.3 Non-Exclusivity – The City has the right to grant another franchise to construct, operate or maintain a cable system.

Section 5.2 (f) Creation and continuously staff a position of "consumer advocate" as a liaison between customers and Zito Media. The contact information will be provided to the City which may in turn be provided to requesters.

Section 6.1 Services to Community Facilities 1.g Zito Media shall provide fiber optic service to City Hall.

Gregory Gebauer was concerned with recourse for the City and Solicitor Wagner responded the cost to install the fiber optic service to City Hall could be billed to Zito Media if they do not provide it.

Nedward Jacob asked if the contract dates were correct and Solicitor Wagner responded yes.

Nedward Jacob stated in the attached Exhibit the Middle School at 325 Church Street needs to be removed.

Motion Passed

Gary Anderson made a motion to approve the Zito Media Franchise Agreement, seconded by Lou Radkowski and all were in favor.

Appointment of Forester to Shade Tree Appeal Board

Manager Pearson explained the appointment of a forester to the Shade Tree Appeal Board was being requested. The forester was recommended by the Public Works Director. The appeal board will consist of the City Manager, Shade Tree Chairperson and the appointed Forester.

Motion Passed

Bob Mohr made a motion to appoint Robert L. Krieg as the forester for the Shade Tree Appeal Board, seconded by Gary Anderson and all were in favor.

Approval of Downtown Economic Development Project Manager Pearson explained an application for funding through the new Downtown Economic Development Program was received from Enchanted Dreams located at 210 Brusselles St. in the amount of \$4,000.00. This application was previously submitted at Council's last meeting and tabled.

Manager Pearson explained the changes to the distribution of funds.

Gregory Gebauer asked who the contractor was and Ms. Gradizzi responded a general contractor.

Manager Pearson explained once all the work was verified the Redevelopment Authority would distribute the funds directly to the contractor and also to the landlord.

Council discussed the start date and opening date and the default requirements.

Bob Mohr made a motion to approve the project, seconded by Andrew Mohney and all were in favor, except Gregory Gebauer and Nedward Jacob who opposed.

Michael McCaig from Janney Capital Markets provided details of the Company's history and ranking. He also provided a refunding history and explained various refinancing options.

Council discussed the presented options.

Henry J. Sallusti from RBC Capital Market, the City's current underwriter, provided details of the Company's history along with a disclosure summary, financing timetable, refinancing options and a savings summary.

Council discussed the presented options.

Manager Pearson and the Finance Director will obtain proposals with similar comparisons and summarize the options for Council's consideration.
